

CHRISTOPHER L. CAMPBELL

Education

Mr. Campbell received his Juris Doctor from Cornell University Law School in 1987, and was admitted to practice in the state of Connecticut in 1987. He was admitted to practice law in California in the year 2000. He is admitted to practice before all courts in the State of California, including the Northern District Federal Courts, the Eastern District Federal Courts, and the United States Court of Appeals for the Ninth Circuit. Mr. Campbell obtained his undergraduate degree from the University of Iowa in 1979.

Arbitration Experience

Mr. Campbell has presided over several high profile doping cases in his over fifteen years of experience as an arbitrator in sports related disputes. He is a member of the Court of Arbitration for Sport, with its seat in Lausanne, Switzerland. He served on the first Ad Hoc Division at the 1996 Olympic Games in Atlanta, Georgia. Practice Areas and Work Experience

Mr. Campbell is currently an attorney with the law firm of Chapman & Intrieri, LLP located in Alameda, California. For eight years Mr. Campbell worked for the fortune 50 company, United Technologies/Carrier Corporation (“Carrier Corporation”), as in-house counsel. His duties included providing advice and counsel on all employment related matters. He worked extensively with the Human Resources Department and established Carrier Corporation’s policies and procedures regarding discrimination, harassment and reductions in the workforce. He conducted seminar across the country on these issues.

In civil litigation, since 2000, Mr. Campbell has successfully represented clients in trial, binding arbitration, administrative proceedings and mediation. Mr. Campbell has also represented clients before the Department of Labor. He has litigation experience in personal injury matters.

In sports, Mr. Campbell has successfully represented Olympic athletes in binding arbitration regarding their right to participate under Article IX of the United States Olympic Committee’s Bylaws. In Federal Court, he has successfully litigated eligibility requirements for National Collegiate Athletic Association (NCAA) athletes.

Accomplishments and Significant Cases

In the sport of Freestyle Wrestling, Mr. Campbell is a 1981 World Champion, selected as the World’s Most Technically Prepared Wrestling at those championships. In 1990, he won a Silver Medal at the World Championships. He was a member of two Olympic Teams: 1980 (boycott year)

and 1992. Mr. Campbell won a bronze medal at the 1992 Olympic Games in Barcelona, Spain, becoming the oldest United States' wrestler to medal in the Olympic Games. He is a two-time NCAA Division I National Champion, a Three-time Big Ten Champion and Four-Time National Freestyle Champion.

Mr. Campbell is the recipient of the highest civilian honor in the United States, the Gold Medal from the United States Congress.

Mr. Campbell was a member of the United States Olympic Committee ("USOC") Board of Directors and Executive Committee from 1992-1996. Mr. Campbell was the Chair and Vice Chair of the Athletes' Advisory Council of the USOC from 1992-1997. He has been a key note speaker for the USOC's best practices seminars regarding Article IX disputes and representing athletes at the Olympic Games. Mr. Campbell was the Executive Director of the Olympic Sport of Boxing from 1997-1998.

At the appellate division level in New York, Mr. Campbell successfully represented clients in a published case regarding an estate matter.
