- Competitive athlete/sailor in various Olympic classes since 1991, **Austrian National Sailing Team** (1993-2004): Helmsman (49er, 470, Laser), several years in the World Cup circuit (including Gold fleets competing in various

European and World Championships, ISAF World Championships). At the end of his Olympic Campaign for the Sydney 2000 Olympic Games, although qualified internationally, no Austrian 49er was sent by the ÖOC (NOC) to those Olympic Games; the last national qualification race (being held at the World Cup in Hyères) was clearly won by Kocholl/Kocholl. The Austrian Sailing team achieved 2 Gold Medals in Sydney. Four times Austrian Champion (1996, 2000, 2001, 2004) in Olympic classes, Bronze Medal at Junior Europeans, Gold Medal as unified partner at Special Olympic Summer Games; 2012: winning an offshore race across the Atlantic Ocean; 2013: competing at Austrian Olympics (2.); 2014: competing at Austrian Offshore Championships; 2017: competing at Barcolana/ITA

- 1986 – 1990: Competitive swimmer (FINA - Butterfly, Breaststroke, Medley)
