He was a former pupil of Lord Justice Anthony Evans at then 4 Essex Court, Middle Temple, England. For many years, he acted for major protection and indemnity clubs and was the Legal Correspondent for Japan P & I and China P & I, ship-owners, shipyards and other marine-related industries.

Currently, he is a visiting professor at 9 Chinese universities, including China University of Political Science & Law, Xiamen University, Renmin University and Wuhan University. He conducts a yearly academic course on Sports Law at the China University of Political Science & Law.

In 2008, he was appointed an adjunct professor at the National University of Singapore. He was instrumental in introducing International Shipping Law at both maritime universities in China. From 2008 to 2012, he taught one of the modules leading to the LLM double degrees from New York University and National University of Singapore.
