Legal Practise

Dato Paul Supramaniam is the Founder and Managing Partner of Law Asia, with offices/ associated offices in Singapore, London, Bangalore, Bangkok, Brunei, Chennai, Colombo, Ho Chi Minh, Jakarta, Kuala Lumpur, Mumbai, New Delhi and Phnom Penh. He trained and practised in London from 1984 to 1992, becoming a Partner in London with a major international firm in 1991, and then helped establish their Singapore office in 1992.

Dato Supramaniam was Joint Managing Partner of Lovells Lee & Lee in the 1990s and then Senior English Law Partner Asia for Latham & Watkins, one of the world's top 10 law firms.

He has led numerous cross border mergers and acquisitions, capital market transactions, privatizations, joint ventures and private equity investments in Asia, Europe and the USA. Examples include: the successful defense for one of the largest contested takeovers in Singapore; the KKR and Silver Lake Partners acquisition of Agilent Technologies for US\$2.66 billion (done as a private equity structured buy-out) creating the then largest privately held semiconductor company in the world; and the PSA bid for CSX World Terminals, comprising ports and terminals in Asia, Europe, Australia and South America.

Dato Supramaniam has also been involved as lead international counsel in number of major cross border dispute resolution matters including securing payment for an international Bank not paid its privatization fee by a regional government, the China Aviation Oil class action litigation and re-structuring (named *"Singapore Insolvency & Restructuring" Deal of the Year 2005*), cross border international arbitrations under ICC, UNCITRAL, SIAC, ICSID; major litigations including contractual claims and defamations; defence contract disputes and sports related matters including the recent 29th SEA Games.

He is ranked in "International Who's Who Legal" as one of the world's leading M&A lawyers, in Chambers Global as an "M&A leading expert in South East Asia", in "Asia Pacific Legal 500" as a "leading practitioner" and in "PLC" as "one of the top M&A lawyers in the region". "Chambers Global" refers to Paul as "known for exceptionally high quality".
