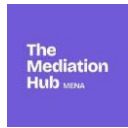

3 Examples of specific professional tasks in the field of ADR

1.- As the Founder of CONCILIA, ADR & Conflict Management since 1999.

CONCILIA provides innovative training and consultancy services regarding the resolution of out of court disputes. CONCILIA collaborates regularly with European, North and South American universities. In 2013 CONCILIA was accredited, as first in Italy, and one of the few in the world, by the Independent Standard Commission of the International Mediation Institute (IMI) as Qualifying Assessment Program (QAP) for experienced mediators who want to seek by the 'International Mediation Institute' the prestigious accreditation as "IMI Certified mediators".

The Company is also accredited by the Italian Ministry of Justice for running training courses addressed to professional civil and commercial mediators; and it is registered in the Register kept by the same Ministry, allowed to manage civil and commercial mediation procedures.

The Company was included in "The Wall of Peace", as the sole Italian partner of Mediators Beyond Borders International (MBBI) for the spread of the 2013,2014,2015 MBBI Congresses; and is Organizational Member of "International Mediators - Community of Practice"; and it is "Country representative", for Italy, of Mediation World.

2.- As an ADR Expert in a Consortium winner of the CARDS project "*Support to the ADR in the Serbian Judiciary*" managed by the European Agency for Reconstruction, Belgrade.

The project had some goals. (1) feasibility studies based on previous experiences and projects; (2) project management and administration, coordination and human resources management of a team of international and local legal experts (7 Members); (3) collaboration with the Serbian Ministry of Justice.

Capacity building component: training and technical assistance to the First Municipal Court of Belgrade for the creation and application of a Court Annexed Mediation Scheme for Out of Court settlements.

Training component: organization and delivery of seminars on Mediation and Conflict Resolution for judges, lawyers, social workers, legal experts, TNA, and training evaluation; coordination and supervision of two Public Awareness campaigns to communicate the improved efficiency of the system through Out of Court settlements.

3.- As an International Speaker and an International Mediation Expert in the project "*Judicial Intercultural Communication in Family Mediation*", funded by the Civil Justice Program (Grant Agreement JUST/2010/JCIV/AG/0025-30-CE-0420858/00-68), 2-5 June 2014, Sofia, Bulgaria, and 30 June- 3July 2014, Cluj-Napoca, Romania.

The project aimed at improving judicial cooperation in civil matters between national judges and overcome the difficulties arising in practice in relation to family mediation in cross-border proceedings, by organizing a series of workshops addressed to judges and other legal practitioners, that provided the opportunity to identify the main common difficulties that legal practitioners encounter in practice and identified viable solutions for a better enforcement of the legal instruments adopted at European level.

One major objective of the project was to identify the specific problems arising from cultural and psychological differences, diversity of traditions and mentality between European citizens. As a result, the project met the need of magistrates and other legal practitioners to determine and to overcome the main issues and problems encountered in family cross-border mediation matters.
