Based in Rio de Janeiro, Vitor Butruce brings together advanced academic credentials, more than 20 years of experience in commercial transactions and disputes, and an active involvement in some of the most prominent sports-related projects carried out in Brazil.

He holds a Ph.D. degree in Commercial Law by the University of São Paulo and is a tenured position as Commercial Law Professor at the University of the State of Rio de Janeiro. He regularly advises major companies in M&A, commercial contracts and construction arbitrations, and has taken part in notable projects in the technology and digital business sectors. His work advising on commercial contracts, arbitration and litigation in football-related matters is widely recognised within the Brazilian football industry, being described at *Chambers Global* as “one of the most sophisticated lawyers in the field in Brazil”. He is an active arbitrator at the Court of Arbitration for Sport in Switzerland and served as the first Chairman of the Brazilian National Dispute Resolution Chamber of the Brazilian Football Confederation (CNRD/CBF).

PROFESSIONAL EXPERIENCE

Sports Dispute Resolution. He is an active arbitrator at the Court of Arbitration for Sport (TAS/CAS) in Switzerland, hearing cases on commercial contracts and international transfers of football players. He was the first chairman of the National Dispute Resolution Chamber of the Brazilian Football Confederation (CNRD/CBF), responsible for more than 1,200 football-related commercial disputes from October 2016 to September 2022. As the former Vice-President for Sports Law of the CBMA, he was responsible for the election of CBMA in 2017 as the independent arbitral institution to hear appeals on decisions of CBF's bodies.

Sports Disciplinary Matters. On the disciplinary side, Vitor acted as Secretary to the Brazilian Code of Sports Justice Reform Act, established under the Sports Law Studies Commission of the Ministry of Sports in 2009. He also acted as Member of the 5th Disciplinary Commission of the Sports Justice Superior Court for Brazilian Football (STJD) from 2012 to 2016, and was an active part of the STJD's defense team in a series of CAS cases that established the limits of CAS' jurisdiction over disciplinary cases regarding Brazilian football, chief among them the landmark *Dodô Case*, which was heard by the Swiss Federal Tribunal.

Commercial Arbitration and Litigation. Vitor renders legal opinions and participates actively in commercial litigation and arbitration projects. Acted in notable cases in the following practice areas:

- **Sports-Related Commercial Litigation and Arbitration.** Advised CBF in litigation related to the commercialization of TV rights of the Brazilian National Football team's matches. Advised one of the main investors in economic rights of football players in the Brazilian market in a large-scale domestic commercial arbitration against one of the top Brazilian football clubs. Between 2020 and 2021, he assisted the successful renegotiation and termination of a complex BRL 1.2 billion pay-tv broadcasting deal with eight of the top-flight Brazilian football clubs.
- **M&A and Corporate Law.** Experience in litigation and arbitration cases involving share purchase agreements, discussions concerning price adjustment mechanisms, breaches of representations and warranties, and indemnification clauses.
- **Construction.** Advises disputes within major construction projects, particularly discussions concerning damages, limitation of liability clauses, contract interpretation and risk allocation in EPC projects.

- **Technology and Digital Business.** Advises some of the major digital platforms present in Brazil in the mobility, lodging and education businesses. Chief among them, he represented Airbnb in a landmark case heard by the Superior Court of Justice that recognized the validity of the company's business model in accordance with the Brazilian Lease Law.

Transactional and Multidisciplinary Projects. Vitor has a 20-year experience in highly complex matters, ranging from corporate transactions and high-value multidisciplinary projects to succession disputes.

- **Sports Major Events.** Vitor had an active role in the legal structuring of the 2014 FIFA World Cup in Brazil, acting as one of the legal managers of the Local Organizing Committee. He is still responsible for the remaining litigation matters related to 2014 FIFA World Cup in Brazil – chief among them a series of public lawsuits filed by the Public Prosecution Service seeking restitution of more than BRL 1 billion spent in the installation of temporary structures by public stadiums owners.
- **M&A Deals.** Vitor collaborates with the M&A team in reviewing complex aspects of transactions during their negotiation, having participated in the operation for the sale of control of the corporation created by Coritiba Football Club in the context of its judicial reorganization, which was awarded Private Equity Deal of the Year by Latin Lawyer in 2024.
- **Commercial Contracts.** He works on the review and planning of commercial and operational contracts for clients in various industries, including the sharing of distribution lines, transitions in production flow models, and the creation of contractual models for service companies.
