In 2022, Dolf was appointed as an arbitrator at the Court of Arbitration for Sport (CAS) in Lausanne.

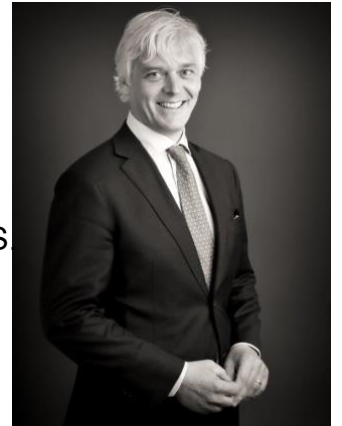
Through his work in sports law, Dolf has gained extensive knowledge of the rules and regulations relating to sport federations.
