I have significant high level dispute resolution experience and am recognised as an accredited employment law specialist by the Law Society of Scotland and am ranked in Legal 500 and Chambers. Having qualified 18 years ago, I am a partner at Level law. I am legally qualified in Scotland and England and Wales and am a qualified Company Secretary and Notary Public.

I am an appointed member of Sport Resolutions' Legal Arbitration panel and am one of the only solicitors in Scotland to sit as Chairman on both the SFA Football Judicial Panel and the SRU Rugby disciplinary panel. For the SFA I have chaired "fast track" disciplinary cases and more involved "main" panel cases and have determined significant high-profile appeal cases on Covid points deductions for premier league clubs and penalties for players who breached Covid government regulations.

In 2021 I was also appointed as an Independent Legal Member of the English FA Judicial Panel. That appointment has subsequently led to me being appointed to the FA's anti-discrimination judicial panel from 2024 onwards and that appointment reflects my discrimination expertise.

In 2023 I was appointed to the Court of Arbitration for Sport in Lausanne as both a football arbitrator and general sports arbitrator.

I sat on the Steering Group of the anti-discrimination charity Nil by Mouth for seven years and assisted their submissions to the Scottish Government on the Offensive Behaviour at Football and Threatening Communications (Scotland) Act 2012. I also presented at their schools' education events.

I am now a trustee and sit on the Board of the UK sports charity Street League which creates employment opportunities through football and sport. The charity works with young people and safeguarding is a principal focus and I sit on the HR sub-committee.

Over several years, my sports law practice has involved acting for football players and managers in exiting clubs and I have negotiated several high profile exits. I have also acted for clubs dealing with player misconduct and drafted player and manager contracts and disciplinary and regulatory rules.

Increasingly many employment cases are resolved by judicial mediation and I have successfully conducted judicial and non-judicial mediations for clients.

I am a noted commentator on employment and discrimination matters and host a podcast series "Employment Law Focus" which discusses hot topics including discrimination in sport. I have written many employment law articles and sports related ones including the undernoted:
